
ANNUAL REPORT 3



In 2012 we celebrated the 100th Anniversary of Girl Scouting in the United States of America. Girl Scouts' proud tradition dates back to founder Juliette Gordon Low, who in 1912 began the organization in Savannah, Georgia. During that same year she helped organize troops in North Florida, and by 1927 we had enough troops operating here to form a Girl Scout Council. From those earliest days Girl Scouts have been blazing trails and building young women into leaders of their community – and the world!

We celebrated Girl Scouts' 100th Anniversary in all corners of our council.





Girl Scouts of Gateway Council and the Ritz Museum hosted **Courage, Confidence, Character** – A history of Girl Scouting in the African American Community in Northeast Florida.



During Girl Scout Week, Jacksonville's iconic **Friendship Fountain** glowed Girl Scout green, and many troops took the opportunity to celebrate, rededicate, and make new friends there.



YEAR OF THE GIRL

Girl Scouts of the USA declared 2012 The Year of the Girl – in recognition of the powerful impact the Girl Scout program has on girls, volunteers and the communities we serve. In 2012 we served 13,485 girls and 5,408 adults, at the cost of \$412 per girl. We provided \$114,443 in financial assistance. We met our membership goals and honored our commitment to girls with a full menu of program activities, special events, leadership and camping opportunities.



Sustaining the Mission

In 2012 we honored **100 volunteers** with a special Sustaining the Mission Award commemorating their continuing service to girls.



Girl Scout Week

During **Girl Scout Week** Gainesville's Oaks Mall was the scene of a Girl Scout flash mob performing songs and choreographed dances. A rodeo, community festival, town centers, parks, city halls and city council meetings were the sites of Girl Scout events and celebrations throughout the council. Girls took active roles in services at churches, temples, and mosques in recognition of Girl Scout Sunday and Girl Scout Sabbath.

Public libraries throughout the council displayed posters, and Girl Scout history displays. Jacksonville Doll and Toy Society created a display of Girl Scout Dolls, Toys and Ephemera at the Main Branch of Jacksonville Public Library. Alachua County's main branch library hosted a display. Clay County and Beaches library showcases were filled with Girl Scout memorabilia and displays created by girls and volunteers.

Campfire, Cocktails & Cookies

We hosted a special evening fundraising event in the Campion Courtyard at Episcopal School of Jacksonville – with the help of an active committee of community volunteers. 200 people attended, and generated approximately \$100,000 of support.

Celebrate a Century

Thousands attended our signature event at the North Fork Leadership Center - enjoying a full weekend of activities, camping and entertainment.



Girl Scout Leadership Awards

In 2012:

- Girl Scout Bronze Award -256 girls invested a minimum of 20 service hours
- Girl Scout Silver Award -86 girls invested a minimum of 50 service hours
- Girl Scout Gold Award -6 girls invested a minimum of 80 service hours

All girls earning these awards used their leadership skills, organizational skills and sense of community and commitment to set the foundation for a lifetime of active citizenship and to fulfill a need within a girl's community.

Collectively, our council's 2012 leadership award recipients donated a minimum of 9,900 hours. The 2011 Independent Sector estimate for the value of a volunteer hour was \$21.79, which means our honorees' volunteer time was valued at \$215,721 – not counting the time of troop mates and adult volunteers who helped them achieve their goals. Congratulations to all our Girl Scout Leadership award honorees.



69% of female U.S. Senators were **Girl Scouts**.

67% of female members of the House of **Representatives were Girl Scouts.**

Virtually every female astronaut who has flown in space was a Girl Scout.

America's most accomplished women in public service, business, science, education, the arts and community life are Girl Scout alumnae.




